

## Entry Requirements to SINGAPORE

You must present yourself for immigration clearance at your point of entry into Singapore. You must satisfy the following basic requirements before you can be considered for entry:

- A passport that is valid for at least six months
- Sufficient funds for the length of your intended stay
- A submitted [SG Arrival Card](#) (Refer to appendix 1)
- A valid Singapore entry visa (to check whether you need a visa, refer to [Visa Requirement](#) in Appendix 2)
- A confirmed onward or return ticket (where applicable)
- Evidence that you can enter your next destination (for example, a visa)
- A [Yellow Fever Vaccination Certificate](#), if applicable
- Travellers are required to adhere to the latest travel requirements and advisories on the [SafeTravel](#) website where applicable.
- A valid REP ( Re Entry Permit) for Singapore Permanent Resident

### VISA REQUIREMENTS

If your travel document is issued by one of the countries/ places listed below, you will require a valid visa to enter Singapore. (For further requirement on individual countries please refer to appendix 2)

### YELLOW FEVER VACCINATION CERTIFICATE

The International Certificate of Vaccination for yellow fever is only considered valid 10 days after vaccination and the validity lasts for the life of the person vaccinated.

You will also need a visa if you are travelling on:

## **VISA FREE TRANSIT FACILITIES**

Nationals of the Commonwealth of Independent States, Georgia, India, The People's Republic of China (PRC), Turkmenistan and Ukraine may be eligible for the Visa-Free Transit Facility (VFTF). (Refer to Appendix 4)

## **SAFETRAVEL REQUIREMENT & ADVISORIES**

Under Singapore's Vaccinated Travel Framework, **all travellers** including Singapore Citizens and Permanent Residents **arriving from all countries/regions can enter Singapore without quarantine, testing or entry approvals if they meet the following requirements:**

1. **Be a child born in or after 2010 (i.e. aged 12 and below by year of birth)** – children who meet this age criteria can enter regardless of COVID-19 vaccination status
2. **Be fully vaccinated with WHO EUL vaccines if born in or before 2009 (i.e. aged 13 and above by year of birth)** – "Fully vaccinated" means at least one dose of Janssen/J&J, or at least 2 doses of AstraZeneca, Covaxin, Moderna/Spikevax, Covishield, Novavax/Covovax/Nuvaxovid, Pfizer/BioNTech/COMIRNATY, Sinovac or Sinopharm. Mixtures and boosters of these WHO EUL vaccines, and vaccination with recovery is also acceptable. Vaccination Status Classifications	Definition
Fully Vaccinated <a href="#">Travel Checklist available here</a>	At least two weeks before arrival in Singapore, the traveller must minimally have taken the following WHO EUL vaccines:
	a. One dose of Janssen/J&J vaccine; OR
	b. Two doses of AstraZeneca, Covaxin, Moderna/Spikevax, or Covishield vaccine, administered at least 24 days apart; OR
	c. Two doses of Novavax/Covovax/Nuvaxovid, Pfizer/BioNTech/COMIRNATY, or Sinopharm vaccine, administered at least 17 days apart; OR
	d. Two doses of Sinovac vaccine, administered 13 days apart; OR
	e. Mixture of any two doses of vaccines listed in points a-d, administered at least 17 days apart; OR
	f. Any of the vaccination combinations listed in points a-e and subsequently recovered from COVID-19; OR
	g. At least one dose any WHO EUL approved vaccines listed in points b – d, taken at least 28 days after the first COVID-19 positive diagnosis, if traveller was not vaccinated before their first infection.
Non-Fully Vaccinated <a href="#">Travel Checklist available here</a>	Travellers are considered non-fully vaccinated if they do not satisfy the conditions above, which includes:
	a. Only vaccinated with COVID-19 vaccines not listed above; OR
	b. Did not complete the minimum dosage of the vaccines mentioned above; OR
	c. Recovered from COVID-19 but did not complete the minimum dosage of the vaccines mentioned above; OR
	d. Medically certified to be ineligible for any COVID-19 vaccines mentioned above.

#### 4) Visa Free Travel Facility

The information on this page is a guide for visitors who may qualify for the 96-hour visa free transit facility (VFTF). This may be available to nationals of the Commonwealth of Independent States (CIS), Georgia, India, the People's Republic of China (PRC), Turkmenistan and Ukraine.

Transit travellers who satisfy the criteria for VFTF will have to meet the prevailing entry requirements before they are allowed entry into Singapore. Assessment for entry is determined by the Immigration & Checkpoints Authority (ICA) officers at the point of entry.

Extension of stay for transit travellers under VFTF is strictly not allowed.

#### **Nationals of India and the PRC**

If you are in transit to or from any third country via Singapore, you may be eligible for the 96-hour VFTF if you meet these requirements:

- You may enter Singapore by any mode of transport but depart only via air or sea. You must have a valid onward air/ferry/cruise ticket departing Singapore within 96 hours; and
- You must have a valid visa\*/long-term pass (with a validity of at least 1 month from the date of entry into Singapore under the VFTF) issued by any of the following countries:
  - Australia
  - Canada
  - Germany^
  - Japan
  - New Zealand
  - Switzerland^
  - United Kingdom
  - United States of America

\* A visa is considered valid so long as it is good for entry into one of the eight countries listed above. Travellers with Single Journey Visas (SVJ) may still be granted VFTF on the return leg of their journey (i.e. after the SVJ is used and no longer valid), but you must:

- Travel directly from the country that issued the SVJ, en route through Singapore, back to your home country
- Not have returned to your home country since you last used the SVJ.

^ Applies to visas issued by Germany or Switzerland, or Schengen visas that are good for entry to Germany or Switzerland.

#### **Nationals of the Commonwealth of Independent States (CIS), Georgia, Turkmenistan and Ukraine**

If you are in transit to or from any third country, you may be eligible for the 96-hour VFTF if you have a valid onward air ticket departing within 96 hours. You may enter Singapore by any mode of transport but must depart Singapore by air.
